

PARTICIPANT RELEASE

(the "Agreement")

PLEASE READ THIS CAREFULLY, THIS IS A LEGALLY BINDING AGREEMENT THAT IS A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS

I hereby choose to participate in programming conducted by Recreational Youth Development and Encouragement ("R.Y.D.E."). As part of such programming, I will participate in outdoor sports and activities including, but not limited to, biking, ice fishing, snowshoeing, and rucking (each of the activities shall constitute an Activity for the purpose of this Agreement).

I hereby acknowledge, agree, and represent that: (i) I possesses the physical fitness necessary to participate in the Activity in a safe manner; and, (ii) I understand that the risks of participating in the Activity could involve serious injury or death.

I further acknowledge that the Activity can be dangerous, regardless of my experience, skill level or the care that I exercise despite all safety precautions taken. I recognize that the risks of harm from engaging in the Activity include being injured by any negligent acts or omissions of any person, including any guest, invitee, customer, owner, officer, agent of R.Y.D.E.. I also acknowledge that there may be other risks not known to me and/or that are not reasonably foreseeable at this time.

I HEREBY EXPRESSLY AGREE TO ASSUME ALL OF THE ABOVE RISKS AND OTHER RELATED RISKS, KNOWN OR UNKNOWN, WHICH MAY BE ENCOUNTERED BY MY PARTICIPATION IN THE ACTIVITY.

In consideration of being permitted to participate in the Activity, I HEREBY WAIVE, RELINQUISH, AND RELEASE ANY AND ALL CLAIMS WHICH I MIGHT HAVE AGAINST R.Y.D.E AND ITS RESPECTIVE AGENTS, OFFICERS, BOARD OF DIRECTORS, PARTNERS, SPONSORS, OWNERS, CONTRACTORS, VOLUNTEERS, AND EMPLOYEES, REGARDING ANY HARM OR INJURY THAT MAY OCCUR TO ME AS A RESULT OF MY PARTICIPATION IN THIS ACTIVITY, resulting from (1) any loss, damage, or injury resulting from my intentional actions or failure to act, or (2) any loss, damage or injury caused by or attributable to the NEGLIGENCE of R.Y.D.E, to the fullest extent allowed by the law. In further consideration of being permitted to participate in the Activity, I hereby agree to indemnify, pay, protect, defend and hold R.Y.D.E. harmless from all losses, liabilities, damages or costs that I may incur arising out of my participation in the Activity resulting from (1) any loss, damage, or injury resulting from my intentional actions or failure to act, or (2) any loss, damage or injury caused by or attributable to the NEGLIGENCE of R.Y.D.E, to the fullest extent allowed by the law. This waiver and release shall be enforceable regardless of whether such liability arises in tort, contract, strict liability, or otherwise. Consistent with the public policy of the State of Minnesota, this Agreement shall NOT be construed in any event to release Company from liability for its own gross negligence or intentional, willful, or wanton acts.

I expressly agree that this Agreement is binding on my estate, heirs, administrators, next of kin and assigns. I agree that this Agreement is the entire agreement between me and R.Y.D.E. with respect to the subject matter set forth herein and that any modifications or changes to this Agreement must be in writing and signed by me and a representative of R.Y.D.E. I also acknowledge that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Minnesota. I agree that if any portion of this Agreement is determined to be invalid or unenforceable, that part will be amended to achieve, as nearly as possible, the same effect as the original and the balance of the Agreement shall remain in full force and effect. I agree that Minnesota law shall govern any dispute connected with or arising out of this Agreement.

I represent and covenant to R.Y.D.E. that I have sufficient personal health, accident and liability insurance to cover injuries and property damage that I could sustain or cause while engaging in the Activity. I certify to R.Y.D.E. that, other than as set forth in writing in the space below or on documents attached hereto, I have no physical or mental conditions, and that I am taking no medication which will adversely affect my ability to engage in the Activity or other activities on or around the Premises:

Any portion of this document deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the remaining provisions.

I HAVE READ THIS PARTICIPANT RELEASE AND I FULLY UNDERSTAND ITS TERMS. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME. I EXECUTE THIS AGREEMENT FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY THE SAME.
